#### **Explanation of Responses:**

(1) These restricted equity units of KKR & Co. L.P. were granted on October 1, 2010 and will vest on October 1, 2011 so long as the Reporting Person continues to serve as a director of KKR Management LLC, which is the general partner of KKR & Co. L.P. The restricted equity units will also vest upon (i) the Reporting Person's death or permanent disability or (ii) a Change in Control as defined in the KKR & Co. L.P. 2010 Equity Incentive Plan. KKR & Co. L.P. will deliver to the Reporting Person one common unit of KKR & Co. L.P. for each vested restricted equity unit.

#### **Remarks:**
