The remaining 825,000 restricted stock units will vest in two annual installments on October 1 of each year as follows: 375,000 units in 2021 and 450,000 units in 2022.
- These shares of common stock are being held by a limited partnership controlled by the Reporting Person solely for purposes of future charitable donations.
