This Form 25 is being filed solely in connection with the discontinuation of the trading on the NYSE of KKR & Co. L.P. and does not affect the continued listing on the NYSE of KKR & Co. Inc.

The Exchange also notifies the Securities and Exchange Commission that as a result of the above indicated conditions this security was suspended from trading on July 2, 2018.
