(1) 102,647 restricted equity units of KKR & Co. L.P. vested on April 1, 2016 and were settled for common units of KKR & Co. L.P. on a one-for-one basis. The remaining 219,423 restricted equity units consist of 12,430, 147,194 and 59,799 restricted equity units, which will generally vest in equal annual installments over a one, two and three-year period, respectively, with the next vesting on April 1, 2017, and upon vesting, may be settled by delivery of common units of KKR & Co. L.P. on a one-for-one basis.
