#### Explanation of Responses:

(1) Represents restricted holdings units granted pursuant to the Amended and Restated KKR & Co. Inc. 2019 Equity Incentive Plan, one-half of which will vest in five equal annual installments, commencing on April 1, 2023 through April 1, 2027, subject to continued service through the respective vesting dates, and one-half of which are subject to market price and cliff service vesting conditions based on average prices of common stock ranging from \$75 to \$115 and the Reporting Person's continued service to April 1, 2027, subject to exceptions. Upon vesting, subject to certain conditions, the Reporting Person may exchange one restricted holdings unit for one share of common stock of KKR & Co. Inc.
