#### **Explanation of Responses:**

- (1) These restricted equity units were approved for grant under the KKR & Co. L.P. 2010 Equity Incentive Plan and will generally vest in equal annual installments over a three-year period with the initial vesting on April 1, 2016. Upon vesting, each restricted equity unit may be settled by delivery of one common unit of KKR & Co. L.P.
- (2) 89,488 of these restricted equity units were previously granted to the Reporting Person and consist of 17,513 restricted equity units of KKR & Co. L.P. that will generally vest on April 1, 2015 and 33,244 and 38,731 restricted equity units of KKR & Co L.P., which will generally vest in two or three equal installments, respectively, on April 1st of each year with the next vesting on April 1, 2015.
